## Staying Home, Staying Safe

As cases of COVID-19 began spiking in the state, Governor Gretchen Whitmer issued an executive order on March 16th barring non-essential visitors from entering health care and direct care facilities.

The direct care and support staff

have done a superb job of reporting to work and caring for the residents. and the administrative staff has provided great

leadership. Non-essential staff working in an administrative support role are now working remotely from their homes.

When staff report to work, they are required to have their temperatures checked, and anyone with potential symptoms from this virus or not feeling well are asked to stay home and selfquarantine.

Construction projects for St. Louis Guanella Village and Martin Hall remodeling have been suspended, and all school and work programs have

The Michigan Governor and State Senate extended the "Stay Home" order through April 30th, and it will be several weeks before things are back to normal. In the meantime, SLC will do everything it can to keep the residents safe.

## From Fr. Enzo

Health, grace and peace to all.

It is very difficult to write to you during these challenging times. A worldwide pandemic has spread, stirring fear and anxieties. We have been called to face this unknown reality, which, like a hidden enemy is attacking us. Constantly, rooted in our faith, we pray to God to spare everyone from it.



COVID-19 has brought changes at St. Louis Center as well.

The school programs have been closed since March 16, 2020, and all off-site work programs have halted. Some residents moved back with their families for the time being. The others are served here at SLC. We are keeping the groups separated, and each group/house is running its activities independently from the others.

Many staff members are working overtime to provide the supervision and care the residents need. A small handful of staff is able to work from home. All the others, who are essential workers, report to SLC to serve the residents.

We were planning for fund raising events to support SLC benevolent care, but due to the present crisis the Pasta Dinner, organized by the Italian American Club of Lansing for April 25, 2020, was cancelled, the Annual Guardian Angel Dinner Dance, scheduled for April 26, 2020 at the Italian American Club of Livonia, has been postponed to September 20, 2020. The SLC 60th anniversary and dedication celebration, scheduled for June 17, 2020, has been postponed to a date yet to be determined. The Golf and Glory Outing has also been postponed; the new date is September 14, 2020. The construction of the new houses and the remodeling of part of the main building have been put on hold until the COVID-19 crisis is over.

In 2010 the SLC administration and members of the Community Advisory Council formed a Legacy Committee to envision the future of the Center. One of the projects was to remodel Fr. Guanella Hall for Assisted Living. It was the right decision for the aging population we are serving now. There, people with intellectual and/ or developmental disabilities can age with dignity and respect. It was a great vision and we knew that sooner or later would become a reality. Julian Early, who spent more than 40 years at SLC, was the first one benefitting from it. He was embraced by God on March 14, 2020 and now he is resting next to his mother.

I want to thank all of you for contributing to the \$555,555.55 matching fund. The total amount raised was \$577,219.38. A big THANK YOU goes to the donor as well. This money will allow us to continue in the vision crafted in 2010 by the SLC Legacy Committee.

Please, keep praying that the pandemic will be over soon and everyone can resume a regular way of life. Please be safe.

## St. Louis Center Remains Active with Political Advocacy Efforts

During the first quarter of 2020, St. Louis Center staff continued to work with local elected officials on behalf of the residents we care for. On Thursday, January 30th, Fr. Enzo, Deana Fisher and Joe Yekulis met with **County Commissioner Jason Maciejewski (D-1st District)**, to discuss efforts on building a better relationship with Washtenaw County Community Mental Health.

On Friday, March 13th, the same group met with **State Sen. Lana Theis** (R-22), who listened to concerns expressed about funding for Home and Community Based Services and how to stream government funds for intended services directly to people with I/DD.

We were contacted personally by **Congressman Tim Walberg** (R-7) on Thursday, March 26, 2020 concerning the availability of loans and grants through the Small Business Administration from the CARES Act just passed by Congress.

#### **Financial Challenges**

Here at SLC, we are taking all measures possible to protect the health and safety of the residents and staff. But the crisis has created financial challenges, as well.

- **1. Reimbursement Reductions** Some publicly funded residents are sheltering with their families resulting in income reductions of \$920 per day.
- **2.** Hazard and Overtime Pay Staffing costs remain high as residents require around the clock care, and overtime and hazard pay for their caregivers.
- **3.** Cleaning supplies and personal protection equipment These have added costs of \$5,000 a month.
- **4. Increased Food Expenditures** In-kind food donations are suspended, increasing our food budget by 25%.
- **5.** Loss of Fundraising Income We raise one third of our operating budget through donations. However, fundraisers are being cancelled or rescheduled, resulting in additional losses.

## Village Updates

#### Weighted Blankets Give Comfort

#### The community has been extremely responsive to the needs of the residents during the "Stay at Home" order in Michigan.

With the onset of the Coronavirus quarantine, the lives of the children we care for have been turned upside down.

For many of them, particularly those with autism, the lack of a routine produces a great amount of anxiety, and many of them are unable to verbalize their fears. They are having difficulty sleeping, and are acting out with behaviors related to this anxiety. Research in the areas of anxiety and trauma has shown

that the use of weighted blankets can help promote a sense of calm and promote sleep.

Deep Touch Pressure (DTP) stimulation is what gives the weighted blanket most of its benefits. When the blanket is being used, it provides the body with the sensory input needed to regulate stimulation



overload. It has a calming effect on the body's senses, addressing sleep problems.

Fifteen new weighted blankets arrived after just a few days.

#### **Construction On Hold**

#### According to Andy Shmina, construction manager of the St. Louis Guanella Village Phase II Building Project,

"We were looking good until the State shut everything down because of the Covid-19 virus. The houses are close to being done, and in various stages of completion. The Administration Building is the furthest along, followed by the family home and the duplex. The group homes are the furthest away with the most work to do. We were scheduled to wrap everything up by June 1st, but now we're out of commission. Martin Hall was scheduled for completion by May 1st, but everything has been pushed back 3-4 weeks. The heating and cooling job is almost done, and hopefully there'll be air conditioning in the main building this summer."


#### **Planning for Dream Tour III**

Dr. Niemann was a strong supporter of SLC for over 40 years, serving as a member of the original Community



Advisory Council from the late 1970s through the late 80s. He provided benevolent dental care to the religious community who never saw a bill for his work. Dr. Niemann was honored with the Founder's Award at the 2019 Fall Dinner Auction, and said "I served as chair of the board, and I was around when they built the first house for the older boys (St. Joseph Hall). I did whatever I could to help them, along with raising money. I helped the Servants of Charity as a part of my Catholic faith, and I have a desire to help people, from my faith and from my heart."



Nancy Wagner of Cave Creek, AZ, passed into the Lord's tender arms on December 22, 2019, at the age of 73. Her husband, Bill, was a founding member of the Golf and Glory Outing in 1995. Nancy was a steady supporter of his efforts to promote the outing through his many friends in the worlds of finance and professional football.
